Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. - Legacy Community Federal Credit Union has no affiliates.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Legacy Community Federal Credit Union does not share with our nonaffiliates so they can market to you.
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include advertising/marketing agencies, CUNA Mutual Group's MEMBERCONNECT, loan recapture programs, and financial advisors.
